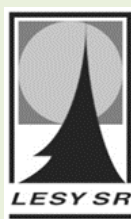

### General Terms

valid from March 1, 2026 to February 28, 2027

State forests reserves the right of a change in prices.

#### A. Individual prices (hunting fees)

1. Hunting guests shall submit an application (annex to this price list) to State Enterprise Forests of Slovakia, (GR), general directorate or to organizational branch of the particular Forest enterprise.
2. The Forest enterprise will approve the hunter's application and send him/her back an **invitation for the hunt**. The invitation is a basis for issuing a firearms accompanying letter for non-EU hunters or for declaring the hunting purposes of journey for holders of The European Firearms Passport when bringing the firearms on the territory of the Slovak Republic.
3. After getting the invitation for the hunt, the hunter shall come to the appropriate Forest enterprise because of dealing the hunting conditions and getting the information about the organization of the hunt. The hunter come to the Forest enterprise on the agreed time, he shall submit the invitation for the hunt, a hunting license and The European Firearms Passport. The director of the Forest enterprise or authorized person by him appoints the hunting area and the guide for the hunt. The permission for hunting is issued for each hunting event separately.  
The Slovak hunting license for the foreign hunting guests and insurance will be provided by the Forest enterprise.
4. The hunting license and the insurance fees for foreign hunting guests ÷  
A weekly hunting license and insurance: EUR **110,00,-**  
A monthly hunting license and insurance: EUR **125,00,-**  
A yearly hunting license and the insurance: EUR **245,00,-**
5. A daily fee in amount EUR 50.00 (to 12,00 p.m. 25.00 EUR, after 12,00 p.m. 25.00 EUR) and daily fee of EUR 60 (to 12,00 p.m. 30.00 EUR, after 12,00 p.m. 30.00 EUR) is charged



for the bow hunting in the game preserve - is charged for each day of an individual hunt. This fee includes the guide and other costs of the hunt organisation.

6. The Forest enterprises can require a deposit charge from the hunters.
7. The license fee includes the trophy preparation.
8. It is possible to order food and accommodation services for hunters with the particular Forest enterprise. These services will be charging individually according to the valid price lists of each Forest enterprise of State Enterprise Forests of Slovakia.
9. The transport during the hunts will be charged according to the following tariffs:
  - bus EUR 1.20,- per km,
  - off-road vehicle EUR 0.70,- per km,
  - car EUR 0.70,- per km,
  - carriage EUR 100,- per day.

The daily fee or all lump prices include a fare for the transport by the off- road car during the wild boar driven hunts so it is not charged separately.

10. Hunting of non-trophy hoofed game (red deer - cow, calf, fallow deer - cow, calf, mouflon - ewe, lamb, roe deer - doe, fawn) and other game bagged according to the directions of driven hunt authorized person (for wild boar) will be priced according to the individual prices of particular game species. Daily hunting (post) fee for non-trophy hoofed game and other game is not charging in this case.

## **B. The lump prices for an individual hunt**

1. The lump price for the hunt will be pay to the account of the Forest enterprise in advance or in cash on the day of hunting event at the latest.
2. Unless otherwise agreed the Forest enterprise will provide the accommodation with the electricity, the shower and the hot water. It is included in the lump price.
3. The lump price does not include the hunting license and the insurance for the foreign hunters. These fees are charging separately in accord of this price catalogue.

## **C. Common terms**

1. An extra charge of 100% of the hunting fee will be charging in case the game animal other than agreed is bagged or wounded.
2. Hunting is finished once the hunter refuses to shoot at the ordered game animal.
3. If there was found a colour of wounded flushing game and the personal of the enterprise assign seeking it by hunting dog the wounded fee will be charging. The trophy of any game recovered after the hunter has departed will be evaluate and given to the hunter after paying the difference between the fees for wounding and hunting.
4. After finishing the hunting event, the authorised person of the Forest enterprise will elaborate a **hunting report** needed for the final settlement of fees. The report shall also be signing by the hunter. Based on the signed report the authorised person of the



Forest enterprise will carry out the final settlement. The hunt is defining as a continuous hunting and accommodation of a hunter. Every day, during which neither hunting nor accommodation of a hunter is invoiced, interrupts the hunt and a new hunt follows.

5. The trophy evaluation will be carrying out in the presence of the hunter up to 24 hours after the trophy preparation. Any claims should be raising before the hunting report are signing. **Only claims stated in the report can be subject to further settlement.** Claim solution is providing by the director of the Forest Enterprise or by him authorized person.
6. Trophy will be deliver to the hunter after paying the finally settled price for hunting.
7. During the wild boar driven hunts a number of games bagged at each hunting site will be obligatory recorded by the authorised person of Forest enterprise. The beasts of prey (e. g. fox) bagged based on permission during driven hunts will be evaluated in terms of individual prices included in this hunting price list.
8. After catching a medal boar in the game - preserve the hunting fee is increased by 100,00 € for bronze medal, 200,00 € for silver medal and 300,00 € for golden medal. In the case, that during driven hunt in game - preserve was caught a boar with the medal tusks evaluated on the one of 3 medals, the fee is paid by hunter.
9. All prices include VAT.
10. On the request of forest enterprise or executive directorate must be trophy by hunting quest submitted to the hunting exhibition for the rating purposes by international CIC committee.
11. At the request of state enterprises or general directorate must be hunting trophy brought forward by hunting guest on hunting exhibition, for evaluation purposes by international committee CIC.
12. The price of sold venison is calculated according to the individual price list aside from duck, wild turkey, hare, woodcock and hazel grouse. In this case, the price of venison is included in the hunting fee.
13. Obligatory ordered and confirmed hunt can be cancel 14 days before the agreed term at the latest. Any cancellation of hunts after these terms is subject to the cancellation fee.
14. It is not possible the combination a lump hunting of non-trophy hoofed game with individual hunting of non-trophy hoofed game during one multi-day hunting event.
15. The hunting season included in this price list can be change due to exception issued by the state administration.
16. State Enterprise Forests of Slovakia reserves the right to cancellation ordered or progressing hunting action without giving a reason.

Individual hunting on non - trophy hoofed game, wild boar, fox and wolf can be realized only within forest enterprises with approved hunting plan or determined quota of Ministry of Agriculture and Rural Development of the Slovak Republic in the hunting grounds with permanent presence of wolf.

Sign up can individual hunter or group of hunters. The State Enterprise Forests of the Slovak Republic reserves the rights before or during the hunting event restrict or forbid hunting on wild game considering actual hunting plan realization or quota determination (wolf).

- bagging the other hooped game and bagging more than 4 pieces will be invoicing according to the individual prices in this price list,

Refunded amount is **100.00 €** in the case, that no wild game is hunted down.

**In the case, that the number of hunters within 1 hunting event will be less than 15, this lump offer is not valid. The invoicing will be realized based on individual prices listed in this price list. The hunting on the other wild game species must be accepted by hunting manager and signed in the hunting permission. In the case, that the hunting guest hunted the wild game, that is not signed in the hunting permission, State enterprise Forests of the Slovak republic invoices 100 % additional charge following the valid hunting price list.
- venison – the hunting guest has the preference right for buying the venison according to the current price list of the State enterprise.
